GUIDELINES FOR ORIGINAL CERTIFICATES VERIFICATION FOR ENSURING ELIGIBILITY OF CANDIDATES ADMITTED BY MANAGEMENT UNDER MANAGEMENT QUOTA/SPOT AND SW-II AND SW-III UNDER MINORITY CATEGORY FOR THE ACADEMIC YEAR 2021-22.

The Principals / Directors of affiliated colleges and affiliated autonomous colleges of JNTUH, offering B.Tech. / B.Pharmacy / M.Tech. / M.Pharmacy / Pharm–D (PB) / MBA / MCA etc. , NRI and admissions through lateral entry (ECET), and also candidates admitted through SW-II and SW-III categories under minority category are informed to get Original Certificate Verification for eligibility of candidates admitted through management for the academic year 2021-22. **Original certificate verification is not required** for candidates taken admission online through convener (admissions) as their certificate verification is completed in presence of candidate at helpline centers under the supervision on competent authority.

Further, submit the list of admitted candidates in all the above categories including convener list along with verification/ratification processing fee in the form of Demand Draft in favour of “Registrar, JNTUH, Hyderabad”, **on or before the cut off dates given in schedule enclosed**, to the Office of The Directorate of Admissions, JNTUH, Kukatpally, Hyderabad-085.

The principal / secretary should make the necessary communication to the admitted candidates to be present for Original certificates verification as per schedule which will be communicated from the University through college portal / E-mail. The principal is requested to submit the following documents on or before the cutoff date to complete verification for eligibility otherwise the admission of the candidate is invalid.

1. A Soft copy of all programs, branch wise admitted candidates details in the format given below.
2. Provisional Approval / Ratification copy of Telangana State Council of Higher Education.
3. Original copy of paper notification issued for 30% of Management quota/Spot admissions etc. and SW-II and SW-III admissions published Leading News Papers.
4. Copy of latest intake sanctioned, branch wise, for the academic year 2021-22 by the University.
5. Recognition copy of the University by AICTE / UGC for the candidates who qualified their qualifying examination from the Universities out side of Telangana State / Andhra Pradesh.
6. A list of admitted candidates under convener quota, specialization wise.
7. A separate list of admitted candidates under management quota & a separate list of admitted candidates under Spot admissions with specialization wise.
8. A copy of ratified/approved letter for the academic year 2020-21 issued by the Director, Admissions, JNTUH.

Submit photo copies of following certificates along with two Passport size photographs.

- (i) Rank Card & Hall Ticket (TS EAMCET/TSECET/TSICET/TSPGECET-2021)
- (ii) S.S.C. or Equivalent certificate
- (iii) Intermediate or Equivalent certificate
- (iv) Convocation Degree Certificate / Provisional Certificate & Memorandum of Marks of Qualifying Examination (CMM)
- (v) Transfer Certificate
- (vi) Caste Certificate
- (vii) Migration Certificate if required
